April showers bring May flowers

April showers bring May flowers. Most of us have heard this saying before. If you lived here at Westlake long enough, you also know that with the showers and flowers, come dogs at large and a few residents wanting fences. If you encounter a dog that is not on a leash, we would hope you and the owner could work it out. If you are not able to work it out with the owner, please call animal control at 815-319-4100. The request for fences is not new. Fences however, do not fit in the the Developers objectives for WLV. (see below Section 1.2 and 4.1 from the Blue Book). They did however take into consideration residents with pets. Residents can submit an application for a dog run up to 6x12 to the ARC committee for approval. You can find more information on a dog run in the Red Book, Section 7.12.



Section 1.2 The Developer desired to proivde for the preservation of property values and amenities in the community and to maintain the lake, open spaces and other common features in the community in excellent condition. To do so, the Developer intended to, and did, subject the real property which comprises the community, and any additional real property which the Developer already added or may add to the community in the future, to the covenants, restrictions, easements, charges, and liens set forth in the Original Declaration, and which remain subject to this Declaration.



Section 4.1 Objectives. Developer's objectives were to carry out the general purposes expressed in this Declaration; and to assure that any improvements or changes in the Properties will be good and attractive design and in harmony with the overall Development and will serve to preserve and enhance existing features of the Development; and to assure that material and workmanship of all improvements are of high quality and comparable to other improvements in the area.



Winnebago County dogs at large and barking laws.

Sec. 14-68. - Dogs running at large.

No person who is the owner of a dog shall cause or permit his dog to run at large in the unincorporated areas of the county which have been subdivided for residential purposes.

(Code 1964, 5-9; Ord. No. 88-CO-82, 5-9, 11-22-88)

Sec. 14-69. - Barking dogs.

It shall be unlawful for any person in the unincorporated areas of the County of Winnebago that are subdivided for residential purposes, or within 500 feet of such areas of unincorporated county, to own, keep, have in his possession, or harbor any dog which, by frequent or habitual howling, yelping, barking, or otherwise, shall cause annoyance or disturbance to any person, provided that the provisions of this section shall not apply to any animal shelter, veterinary hospital or clinic, or to the county animal shelter.

(Code 1964, 5-10; Ord. No. 88-CO-82, 5-10, 11-22-88; Ord. No. 94-CO-72, 11-22-94; Ord. No. 2010-CO-43, 5-13-10)

Sec. 14-81. - Penalty for violation of division.

Any person violating or aiding or abetting the violation of any provision of this division, or resisting, obstructing or impeding the administrator or any authorized officer in enforcing this division, is guilty of a petty offense and may be punished by a fine of not less than \$50.00 and not more than that provided in section 1-11.

(Ord. No. 88-CO-86, 3, 12-22-88)

Sec. 1-11. - General penalty for violation of Code; separate offenses.

Whenever in this Code, or in any ordinance, resolution or motion of the county, any act or omission is prohibited or is made or declared to be unlawful or an offense, or whenever in the Code or ordinance, resolution or motion the doing of any act or the failure to do any act is declared to be unlawful or an offense or is prohibited, and no specific penalty is provided therefor, and state law does not provide otherwise, the violation of any such provision of this Code or any ordinance, resolution or motion shall be an offense punishable by a fine of up to \$500.00. Unless specifically provided otherwise, or the context thereof so dictates, each day any violation of any provision of this Code or any ordinance, resolution or motion shall continue shall constitute a separate offense.




